IV International Scientific and Theoretical Conference "Actual Problems of World Philosophy"

L.N. Gumilyov Eurasian National University with the Institute of Philosophy, Political Science and Religious Studies of the CS MSHE RK announces **the IV International Scientific and Theoretical Conference "Actual Problems of World Philosophy" on February 16-17, 2023.**

The decision to hold the conference on actual issues of world philosophy in Astana as an international scientific dialogue platform, once every five years was made within the walls of L.N. Gumilyov ENU at the first conference in 2008 dedicated to the 75th anniversary of Zhabaikhan Mubarakovich Abdildin. The IV International Scientific and Theoretical Conference continues the tradition of philosophical dialogue with domestic and foreign philosophers of our time, is designed to unite the philosophical community, expand and deepen the scientific contacts of researchers, and integrate the results of scientific research in the field of philosophy and ethics.

Purpose: Discussion of topical issues of philosophy and ethics in the system of modern world socio-humanitarian knowledge, and in the context of new challenges of the current modernity, rethinking the key problems of the philosophical heritage of the Kazakh people.

The conference will honor the Doctor of Philosophy, Academician of the National Academy of Sciences of the Republic of Kazakhstan Zhabaikhan Mubarakovich Abdildin, in connection with the 90th anniversary.

Abdildin Zh.M. - Laureate of the State Award of the Kazakh SSR in the field of science and technology, the Interstate Award "Star of the Commonwealth", the Presidential Award for Peace and Spiritual Harmony, the Russian Award "Tree of Life", Laureate of the first prize named after Ch. Valikhanov, holder of the Order "Barys" II degree, holder of the Order "Barys" III degree.

Academician Zhabaikhan Mubarakovich Abdildin made a great contribution to the development of domestic and world philosophical thought, in particular, to the development of the problems of dialectical logic and the theory of knowledge, the history of philosophy and the methodology of science. He is the recognized head of the Kazakh school of dialectical logic. On the basis of dialectical methodology Abdildin Zh.M. also develops the problems of Kazakh philosophy, the creative formation of personality, democracy, the development of a modern state.

The conference program provides for plenary and breakout sessions in a hybrid format: a plenary session at the solemn Academic Council at ENU - in an offline format, sections - in an online format.

The working languages of the conference are Kazakh, Russian, English.

The Organizing Committee has the right to select reports when compiling the program and collection of conference materials. Abstract (200–250 words) and keywords (no more than 6 words) in English.

References in the text in square brackets.

References: font size 12, single spacing.
